Liability Waiver

On behalf of myself, my family, and my guests, I release from liability and hold Whitney Ranch Community Association harmless any damage, injury and/or claim of any kind, whether to person or property as a result of such activities, and waive claims that I, my family, and/or my guests, may otherwise acquired against Whitney Ranch Community Association its officers and directors, agents, or employees, the releases for any injury occurring to me, my family, or to my guests, whether to person or to property, as a result of any use of the Whitney Ranch Community Association property or participation in recreational activities on the facilities and grounds of Whitney Ranch Community Association and even the negligence of the releases, located in Rocklin, California. Said releases shall not extend to the sole negligence, sole willful misconduct, nor sole gross negligence of the releases.

I have read the community guidelines, Whitney Ranch Rules and Regulations and the Whitney Ranch Liability Waiver. I accept the liability for damage to Whitney Ranch Community Association property and for injury to persons admitted to Whitney Ranch. I understand that in the event that I, my family, and/or my guests violate and of the regulations, or if I provide inaccurate information on my application, Whitney Ranch Community Association reserves the right to cancel my club access at any time and charge for any and all expenses incurred by this violation.
